5. Gospel-Centered, Relational and Redemptive Church Discipline

- ➤ Biblical discipline is always three-dimensional
 - God-aware: "How can we please and honor God in this situation?"
 - Self-aware: "How do we guard against our own sinful motives and act with pure hearts?"
 - Other-aware: "What is it that has captured this person's heart and how can we be used by God to lovingly rescue and redeem this person?"



Benefits of redemptive discipline

- For the good of the person disciplined (1Cor.5:1-5)
- For the good of other Christians (1Tim. 5:20)
- For the health of the Church as a whole (1Cor.5:6-8)
- For the corporate witness of the Church (Mt. 5:16)
- For the glory of God as we reflect his holiness (Eph.5:25-27)

Practical Goals

- Saturate the entire process with prayer and loving concern
- Instill HOPE of forgiveness, reconciliation and restoration
- Instruct the church before, during and after each step
- Try and keep a conversation going with person, not fellowship, but open when they are ready to talk
- Document everything
- Remember, this is a gospel opportunity
