- 1. Healthy churches are relational churches (Matt. 22:37-39).
- 2. Relational churches have relational leaders (1 Thess. 1:7-8).
- 3. Relational leaders realize that there is <u>one relationship that is rarely restored</u>.
- 4. Relational leaders know that <u>wisdom is relational not informational</u> (James 3:17)
- 5. Relational leaders realize that sin can turn strengths into weaknesses (1 Cor. 8:1).
- 6. Relational leaders understand the seductiveness of power and its potential for abuse.
- 7. Relational leaders are <u>always bringing the gospel to their people</u> (Rom. 5:1-11).
- 8. Relational leaders develop their capacity for <u>empathy and compassion</u> (Col. 3:12).
- 9. Relational leaders tend their flocks like a shepherd (Isa. 40:11).
- 10. Relational leaders use church discipline to redeem and restore lost sheep.
- 11. Relational leaders are both <u>approachable</u> and <u>accountable</u> (Luke 7:37-38; Matt. 8:9).
- 12. Relational leaders are always building passport (John 4:7-30).
- 13. Relational leaders study their people (Mark 6:34; Reagan, Lincoln, RW, and You).
- 14. Relational leaders practice <u>clarity plus charity</u> (Matt. 7:12)
- 15. Relational leaders are skilled peacemakers (Matt. 5:9; James 3:18).
- 16. Relational leaders know how to defuse explosive meetings (Matt. 7:3-5).
- 17. Relational leaders use relational wisdom to exalt Christ is every challenge of life, including <u>cancer</u>.
- 18. Relational leaders know that smooth leadership transitions are characterized by <u>TRUTH</u> (Transparency, **R**eality, **U**nity, Timeliness, **H**umility).
- 19. Relational leaders equip their people to <u>use the principles of relational wisdom and</u> <u>peacemaking for witnessing and evangelism</u>.
- 20. Relational leaders use <u>Relational Commitments</u> to obtain informed consent to their policies and practices, which reduces conflict and exposure to legal liability.
